It is an Open Access journal that permits authors to self-archive the final accepted version of the articles on any Open Archives Initiative (OAI)-compliant institutional/subject-based repository. The Editorial Board of EDRBJ consists of eminent investigators in the field of dentistry from across the globe and presents an ideal international composition. EDRBJ encourages submissions from all authors worldwide. Manuscripts are judged by experts solely based on their contribution of original data and ideas, and their

presentation. All manuscripts must comply with the Author Instructions.

The following articles are considered for publication: **Original Articles, Brief Reports, Reviews, Editorials, and Letters to the Editor**. Submitted manuscripts must not have been published, accepted for publication, or be under consideration elsewhere.
